Your campaign. One business, one approved concept, one language, one voice and one short custom sung jingle direction (typically 8-12 seconds). Includes script development and up to five generated shots or suitable client-supplied visuals. AI tools assist with visuals, music and narration; editing and review are handled by FoFo Media.

Files included. One 30-second ad plus 15- and 6-second edits. Each duration comes in landscape (16:9) and vertical (9:16), with clean and captioned versions: 12 MP4 files. Also included: three SRT caption files, a jingle WAV and a short audio-logo WAV. These are finished files; editable project files, isolated music stems and a full-length song are not included.

Payment and schedule. USD \$245, paid in full through a PayPal Business invoice before production. Any legally required taxes are disclosed on the invoice before payment. The seven-calendar-day delivery target starts when payment and complete intake are received; we confirm the start and target date by email. Script/direction approval is needed before full production. Please return approvals or consolidated feedback within one business day. Client delays move the target by the corresponding delay; any other extension is agreed in writing.

Review and revisions. Two consolidated revision rounds within the approved concept are included: captions, timing, audio balance and agreed text edits. Our production mistakes are corrected without consuming a round. New concepts, replacement scripts after approval, extra languages, voices, formats or deliverables require a separate written quote before extra work begins.

Commercial use. After full payment and delivery, the client receives a perpetual, worldwide, non-exclusive license, to the extent we can grant it, to use the finished ad and supplied jingle/audio-logo files for the named business's website, organic social posts and paid digital advertising. Source-asset restrictions are disclosed and agreed before use. Client assets retain their existing rights. Exclusive ownership or copyright in AI-generated output is not promised. Broadcast, resale, sublicensing and standalone music distribution need separate written review. Public portfolio use requires the client's separate permission.

Client materials and boundaries. The client confirms permission for supplied logos, photos, clips, music and likenesses, and the accuracy of business details, offers and claims. Generated scenes are illustrative, not evidence of actual staff, installations or results. Ad placement, media buying, platform approval and sales or lead guarantees are not included.

Cancellation and acceptance. Cancel before production starts for a full refund. After work starts, uncompleted work is refundable; any retained amount must be itemized and agreed in writing, with no extra cancellation fee. If we cannot complete the agreed scope, we refund the undelivered portion. Before payment, reply by email accepting this scope version and the agreed campaign summary. For an order placed on Fiverr, its order terms and platform process apply instead.
